### **Minutes of the Last Meeting**

### **Matters arising from the Minutes**

The following items continue needing attention:

Trees need cutting back near Cwmseiri.

White lines on the roads need painting, urgently required at Llanfihangel-y-Creuddyn and Cnwch Coch.

The flashing warning lights outside Llanfihangel-y-Creuddyn School come on at times, inconsistent with school hours – lights seem to have stabilised to appropriate timings.

Near Tanllan corner, Llanfihangel-y-Creuddyn the sharp corner sign has been damaged and in need of re-installation.

Flooding on the road near New Cross is continuing. In the hands of officers of
