A number of historical issues needing attention, Ceredigion County Council has acknowledged the reporting of these matters, it will be necessary to wait for the work to be completed and occasionally bring the issues to the attention of the County Council if they have not been acted upon.

Landslide near the side of the River Ystwyth behind Abermagwr. Awaiting response of contact for landowner.

The following have been referred to the County Council.

Pot holes on the road near Llanfihangel-y-Creuddyn School.

Culvert/Open drain by Brynhyfryd, Llanfihangel-y-Creuddyn still needs attention, the large hole at the location is dangerous.

Growth from the hedgerows need cutting on Ffordd Uchaf Llanafan, as well as left hand side between the junction to Cnwch Coch and Abermagwr. Ceredigion County Council investigating.

Bont Sigl, Llanafan: County Council has closed the bridge due to safety. Contact to be made with the County Council to enquire how long it will be closed.

Blocked water drains on the road between Llanafan and the B4340 causing flooding on the B4340.
