Nid yn unig y mae'n lleihau'r ddarpariaeth parcio ond byddai llety byw'n cynyddu'r gofynion parcio yn yr ardal lle mae llefydd eisoes yn gyfyngedig. Mae'r datblygiad yn ffinio â chyffordd a chroesffordd brysur a leolir ar ran cyflym o'r B4340 lle y byddai cerbydau o bosibl yn parcio ger y gyffordd neu ar ochr ffordd y B4340 a fyddai'n gosod peryglon ychwanegol i ddefnyddwyr y ffordd.

area of land and if there was planning consent for a garage. Councillors would ask Officers to look at the original planning application and consent.

The building in question, built in recent months, does seem rather high in construction to be an intended garage and prominently overhangs the roadside hedge of a busy main road and potentially been purpose built for accommodation with an application for retrospective planning which the Community Council can't condone.

The Community Council is concerned regarding the parking situation on site. If the site was intended as a garage or parking facilities for the two new built adjoining houses, taking away this provision reduces the parking spaces for those houses. Not only does it reduce parking provision but a holiday let would increase the parking requirements in the area where spaces are already limited. The development is adjoining a busy junction and crossroads and on a fast section of the B4340 where potentially vehicles would park near the junction or on the B4340 roadside which would impose additional hazards to road users.

There is no specific details of drainage of water and sewerage for the building and Community Councillors would need relevant information before they could comment to ensure that there would be no flooding or odour problems emanating from this development.
