### **Reduce speed restriction through New Cross**

A request to reduce the Speed limit through New Cross was discussed.

It was decided to contact Ceredigion County Council requesting to reduce the maximum speedlimit from 40 m.p.h. to 30 m.p.h. on safety grounds as there are a number of entrances within the village and also quite a bit of activity next to the B4340 road in the Centre of New Cross Village.
